

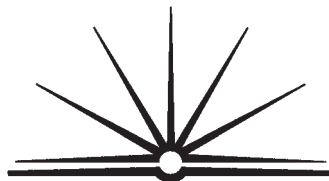

Introduction

The *Education Act 1990* (NSW) governs the award of the Higher School Certificate. The Board of Studies, under this Act, grants certificates to students who comply with the Act and the Board's requirements.

The main rules and requirements are set out in this booklet. Students can obtain more detailed explanations of the rules and requirements by referring to the *Assessment, Certification and Examination Manual*. A copy of the manual is kept in every secondary school and college of TAFE in NSW and many council libraries. It can also be downloaded from the Board of Studies website at www.boardofstudies.nsw.edu.au/manuals.

1. Eligibility requirements for the Higher School Certificate

To be eligible for the award of the Higher School Certificate you must have:

- (i) gained the School Certificate or such other qualifications as the Board of Studies considers satisfactory
- (ii) attended a government school, an accredited non-government school, a school outside NSW recognised by the Board, or a college of TAFE
- (iii) satisfactorily completed courses that comprise the pattern of study required by the Board for the award of the Higher School Certificate
- (iv) sat for and made a serious attempt at the required Higher School Certificate examinations.

Pattern of study

To qualify for the Higher School Certificate you must satisfactorily complete a Preliminary pattern of study comprising at least 12 units and an HSC pattern of study comprising at least 10 units. Both patterns must include:

- at least six units of Board Developed Courses
- at least two units of a Board Developed Course in English
- at least three courses of two-unit value or greater (either Board Developed or Board Endorsed Courses)
- at least four subjects.

HSC: All My Own Work

All students undertaking one or more Preliminary or HSC courses must first complete the *HSC: All My Own Work* program in ethical scholarship (or its equivalent). This program is delivered through your school and will assist you to understand your rights and responsibilities in HSC assessment.

2. Accumulation of the Higher School Certificate

You may accumulate HSC courses towards the Higher School Certificate over a period of up to five years. Preliminary courses may also be accumulated.

The five-year period is counted from the first year you satisfactorily complete an HSC course. It will apply regardless of whether you defer your studies for one or more years during the five-year period. Accumulation of HSC courses cannot extend beyond a five-year period. This five-year period is a 'rolling period' and students wishing to go beyond the five years will have the earliest year's course(s) deleted.

Students who are accumulating courses for the Higher School Certificate will receive a Record of Achievement for each calendar year of study. These cumulative transcripts record all Preliminary and HSC courses satisfactorily completed in the previous five years, including repeat attempts.

On completion of the accumulation, all requirements must have been met for both the Preliminary and HSC patterns of study.

3. Repeating courses

You may repeat one or more HSC courses, but you must do so within the five-year accumulation period. The universities will use the most recent result for a course in the calculation of your Universities Admission Index (UAI).

4. Entering for the Higher School Certificate

You must be entered for all courses you are attempting in the current year, including those courses studied outside the school or college. You will receive a Confirmation of Entry with your personal details and courses listed. You must sign the declaration printed on the Confirmation of Entry and return it to your school principal.

5. Corrections to entries and withdrawals

- (i) You must check your Confirmation of Entry and notify your school of any changes as soon as possible but **no later than 30 June**.
- (ii) A new Confirmation of Entry will be issued when the changes are made. You must sign and return it to the school principal.
- (iii) The only change to entries allowed after 30 June is withdrawal from a course (including an extension course).

6. Students Online

The Students Online website <<http://studentsonline.bos.nsw.edu.au/>> lets you log in to view your HSC entry details. By using your student number and PIN provided by the Board, you will be able to check important details relating to your enrolment and view important information such as your personalised HSC written exam timetable, your Assessment Rank Order (after the final HSC examination) and information regarding your HSC results. In addition, Students Online has personalised links to course syllabuses, past papers, marking guidelines and notes from the marking centre. There are also answers to frequently asked questions about the HSC.

You can change your personal details and address on Students Online after the final examination date, provided that you supply the Board with an email address.

7. Eligibility for courses

There are specific eligibility rules for:

- all Beginners Language courses
- Continuers Language courses in languages where there is also a Background Speakers course (Chinese, Indonesian, Japanese and Korean)
- English (ESL).

Certain rules and prerequisites also apply to the study of Extension courses.

It is your responsibility to ensure that you are eligible to undertake the courses for which you are entered. You could jeopardise your HSC if you enrol in a course for which you are not eligible. (See the *Assessment, Certification and Examination Manual 2005*).

8. Transferring schools

If you transfer from one school to another after entering for the HSC, you must ensure that your new school has informed the Board. Once the Board has been informed of your transfer, you will receive a new Confirmation of Entry. This will allow you to sit for all examinations that take place after the date of your transfer at the examination centre for your new school.

9. Study with an outside tutor

If you wish to study a course with an outside tutor, you must study at least eight Preliminary and eight HSC units at an accredited or recognised school. Your principal may give approval for you to study a course with an outside tutor provided that the Board's conditions are met. Outside tutors must follow the Board's syllabus and provide assessment marks in accordance with syllabus guidelines. These assessment marks will only be used in the case of an illness/misadventure appeal (see section 22).

10. Honesty in Assessment – the Standard

The following standard sets out the Board of Studies NSW requirements concerning students submitting their own work in HSC assessment. Candidates for the Higher School Certificate, as well as their teachers and others who may guide them, are required to comply with the standard.

The honesty of students in completing assessment tasks, examinations and submitted works, and of teachers and others in guiding students, underpins the integrity of the Higher School Certificate. Throughout the assessment process, the highest level of honesty is required.

Each student's mark will be determined by the quality of the work produced by the student only. To demonstrate honesty, any component of a student's work that has been written, created or developed by others must be acknowledged in accordance with the Board's subject specific documentation. Use or inclusion of material from other sources such as books, journals and electronic sources, including the internet, must be acknowledged. General teaching and learning do not require formal acknowledgement.

Dishonest behaviour carried out for the purpose of gaining unfair advantage in the assessment process constitutes malpractice, or cheating. Malpractice in any form, including plagiarism, is unacceptable. The Board of Studies NSW treats allegations of malpractice very seriously and detected malpractice will limit a student's marks and jeopardise their HSC. Should malpractice be suspected, students will be required to demonstrate that all unacknowledged work is entirely their own. Serious and deliberate acts of malpractice amount to corrupt conduct and, where appropriate, the Board of Studies NSW will report matters to the Independent Commission Against Corruption.

These requirements should be read in conjunction with Board syllabuses and policies in related areas such as malpractice and satisfactory completion of a course. Details can be found on the Board's website at www.boardofstudies.nsw.edu.au/hsc_assessment_policies/honesty.html.

11. What constitutes malpractice

All work presented in assessment tasks and external examinations (including submitted works and practical examinations) must be your own or must be acknowledged appropriately. Malpractice, including plagiarism, could lead to you receiving zero marks and will jeopardise your HSC results.

Malpractice is any activity that allows you to gain an unfair advantage over other students. It includes, but is not limited to:

- copying someone else's work in part or in whole, and presenting it as your own
- using material directly from books, journals, CDs or the internet without reference to the source
- building on the ideas of another person without reference to the source
- buying, stealing or borrowing another person's work and presenting it as your own
- submitting work to which another person, such as a parent, coach or subject expert, has contributed substantially
- using words, ideas, designs or the workmanship of others in practical and performance tasks without appropriate acknowledgement
- paying someone to write or prepare material
- breaching school examination rules
- using non-approved aids during an assessment task
- contriving false explanations to explain work not handed in by the due date
- assisting another student to engage in malpractice.

In the case of suspected plagiarism, students will be required to provide evidence that all unacknowledged work is entirely their own. Such evidence might include but is not limited to the student:

- providing evidence of and explaining the process of their work, which might include diaries, journals or notes, working plans or sketches, and progressive drafts to show the development of their ideas
- answering questions regarding the assessment task, examination or submitted work under investigation, to demonstrate their knowledge, understanding and skills.

12. School-based assessment

For most Board Developed Courses, school-based assessment throughout the HSC course contributes 50% of your HSC mark, and is reported on your Record of Achievement.

For each course, schools prepare and administer an assessment program in accordance with the syllabus. The syllabus identifies the components of the course to be assessed and their weightings. The timing and weighting of tasks is determined by the school.

Assessment tasks are designed to measure knowledge, skills and understanding in relation to a wide range of outcomes. Tasks may include tests, written assignments, practical activities, fieldwork and projects.

When you begin your HSC course, your school will provide you with details of your assessment tasks, including weighting and due dates.

All work presented in an assessment task must be your own. Malpractice, including plagiarism, could lead to you receiving zero marks (see sections 10 and 11).

At the conclusion of the HSC assessment program, your school will submit a school-based assessment mark to the Board for each of your courses based on your performance in the tasks in your school's assessment program. The assessment mark submitted by your school is adjusted (moderated) by the Board to produce the assessment mark that appears on your Record of Achievement (see section 25). The purpose of moderation is to place the assessment marks awarded by all schools in each course on the same scale. The school group's assessment marks are adjusted based on the performance of the group in the HSC examination. The rank order of students as submitted by the school is not changed.

No assessment mark is reported for VET courses and courses studied with an outside tutor.

13. Work placement

The courses in the Vocational Education and Training (VET) Industry Curriculum Frameworks have been designed to deliver units of competency that are drawn from Industry Training Packages.

Work placement is a mandatory HSC requirement of each framework course and for some other VET courses. For each course, a minimum number of hours is required in the workplace to enable students to progress towards the achievement of industry competencies and to practise skills acquired in the classroom or workshop. If you fail to undertake any mandatory work placement component of a VET course, it may be determined that you have not made a genuine attempt to complete course requirements (see section 14).

14. Principal's certification of completion of course requirements

- (i) You will be considered to have satisfactorily completed a course if, in your principal's view, there is sufficient evidence that you have met the following course completion criteria:
 - (a) followed the course developed or endorsed by the Board; and
 - (b) applied yourself with diligence and sustained effort to the set tasks and experiences provided in the course by the school; and
 - (c) achieved some or all of the course outcomes.
- (ii) For courses where school assessment marks are submitted, students must make a genuine attempt at assessment tasks that total more than 50% of the available school assessment marks for that course.

- (iii) If your principal determines that the above course completion criteria are not being met, you will be given written warning in sufficient time to correct any problems regarding your satisfactory completion of course requirements. A student who has not complied with the above requirements cannot be regarded as having satisfactorily completed the course. The principal will then issue an 'N' determination (non-completion of course requirements) for that course.
- (iv) You have the right to appeal to the school against this determination. If unsuccessful, you may appeal to the Board. Your principal will advise you of this right and explain the appeal process.
- (v) If you receive an 'N' determination for a course, you will receive no results in that course. Until you receive results in 12 Preliminary units and 10 HSC units, you will not be eligible for the award of a Higher School Certificate.

15. External HSC examinations

Your examination mark for Board Developed Courses will be based on your performance in the external HSC examination. The examination may involve more than one component, such as a written examination, a submitted work or a practical examination. There is no external HSC examination for Board Endorsed Courses.

- (i) The following courses require you to undertake practical examinations or to submit works as part of your HSC examination requirements:

Agriculture (optional research project)

Dance

Design and Technology

Drama

English Extension 2

Industrial Technology

Languages (except Classical languages and Background Speakers courses)

Music (all courses)

Society and Culture

Textiles and Design

Visual Arts

- (ii) HSC performances and practical examinations as well as projects submitted for examination should be consistent with general community standards. Such works should be developed in a manner that takes into account the values and culture of the school and its community. This also applies to the material that students are permitted to take into some Languages oral/speaking examinations to support their conversation and/or discussion.
- (iii) You are required to certify that any submitted work is your own, and that any words, ideas, designs or workmanship of others have been acknowledged appropriately (see sections 10 and 11). Class teachers and principals must certify that the work has been done under the teacher's supervision, was the student's own work consistent with earlier drafts and other examples of the student's

work, and was completed by the due date. If school staff cannot certify the work, you might not be awarded marks for it, or you may receive reduced marks. If you are planning a project that will need to be worked on at home, you must obtain your teacher's permission first.

- (iv) If you are repeating a course where a submitted work is required, you cannot submit any work entered and marked for the HSC in a previous year without the special permission of the Board.

If you developed a major work for a previous HSC examination but did not submit it, you may only submit it for your current course with the approval of your school.

- (v) If you submit a work developed for one course, you may not use the same work either in full or in part for assessment in any other course.
- (vi) All submitted works (other than those created electronically) will be returned after marking. Some works will be retained until the following year. While every care will be taken with them, the Board accepts no responsibility for loss or damage to such works. It is your responsibility to arrange any insurance. Teachers will advise you about the packing of submitted works.
- (vii) Students intending to submit works in print or electronic format should keep copies.
- (viii) You should refer to each syllabus you are studying for specifications relating to submitted works.
- (ix) The Languages oral/speaking examinations and practical examinations for Music, Dance and Drama are held earlier than the written examinations and may be held at different locations. Advice about this will be sent to you or your school.
- (x) Languages oral/speaking examinations and practical examinations are held during Term 3, and submitted works are to be completed during Term 3. You are advised to check the Board website to ensure you are aware of the correct dates.

16. Special examination provisions for students with special needs

- (i) If you have a special need that would, in a normal examination situation, prevent you from:
 - reading the examination questions; and/or
 - communicating responses,
 the Board may approve special examination provisions.
- (ii) Applications for known conditions are due by early April, although your school may submit your application by the end of Year 11 so that you will receive a decision in early Year 12. Late applications will be considered if your special need first becomes known to you after this date. If you wish to apply for special examination provisions you should ask your principal or Year adviser or school counsellor about lodging an application with the Board of Studies.
- (iii) Emergency provisions can be arranged if you have an accident just before the examination. You should immediately notify your principal or Year adviser in such a case.

- (iv) Your application should contain recent evidence of your special need and, in some cases, examples of your work. You may need to organise any testing required early in the year to ensure your application reaches the Board by the closing date. If applications do not contain sufficient evidence, the Board's decision may be delayed.
- (v) Special examination provisions are not available:
 - as compensation for difficulties in undertaking a course and preparing for the examination
 - for lack of familiarity with the English language.
- (vi) Certain special examination provisions may not be available for oral/speaking examinations, performances and projects.

17. Examination dates and times

- (i) The Board publishes the examination timetable on its website in Term 2 and sends copies to schools for distribution to students. It is your responsibility to obtain a timetable and read it carefully. You can access a personalised HSC timetable via Students Online.
- (ii) If you miss an examination simply because you have misread the timetable, you must contact your principal immediately. You cannot lodge an illness/misadventure appeal on these grounds. You will receive an examination mark of zero in that course, but you may still retain eligibility for the award of a Higher School Certificate and Record of Achievement.
- (iii) On the day of the first English examination, you must be at the examination location by 9 am. For all other papers, you must be at the examination location at least 10 minutes before the start of each examination.
- (iv) If you arrive more than one hour after the commencement of the examination, you will not normally be admitted to the examination room.
- (v) You must be prepared to attend examinations at your own expense at such times and centres as may be arranged by the Board.

18. Examination attendance rules

- (i) You must sit for your examinations at the centre you have been given, even if you have studied a course at a different location.
- (ii) You can only sit for examinations in the courses for which you have entered. You are not permitted to change courses or add courses during the examinations.
- (iii) You must sit for all examinations for which you have entered, unless prevented by illness or misadventure. If you cannot attend an examination because of illness or misadventure, notify your school principal immediately.
- (iv) If illness or misadventure occurs before the examination and you are still able to attend, notify the presiding officer when entering the examination. The presiding officer is responsible for the administration of the HSC examination at each centre. If a problem occurs during an examination, you should notify the presiding officer at once.

- (v) You must notify the presiding officer at every examination session in which you consider your performances may have been affected by illness or misadventure.
- (vi) If you are absent from an examination and your illness/misadventure appeal is declined by the Board, you will not receive any result in that course. This could mean that you become ineligible for the award of the Higher School Certificate.
- (vii) Except for Mathematics Extension 2 candidates, if you have entered for an extension course and fail to sit for the examination in the related two-unit course, you will not receive any result in the subject unless an appeal is submitted and upheld by the Board.
- (viii) If you are an English Extension 2 or Mathematics Extension 2 candidate and you fail to sit for the related Extension 1 examination, you will not receive a result in the Extension 2 course unless an appeal is submitted and upheld by the Board.

19. Equipment for the examinations

- (i) The HSC examination timetable contains a list of:
 - (a) equipment that you are expected to provide
 - (b) optional items that you may bring if you wish.

It is your responsibility to make sure you obtain this list, which appears on the Board's website at

www.boardofstudies.nsw.edu.au/manuals/#equipmentchecklist.

- (ii) Before the examination begins, presiding officers and examination supervisors will inspect any equipment brought into the examination room.
- (iii) Equipment should bear only the original inscribed information. You must supply materials that are in working order (this includes calculators). You cannot lodge an illness/misadventure appeal on the grounds that your examination equipment did not work correctly.
- (iv) For the examinations in which scientific calculators are permitted, you may only use those calculators that appear on the Board's list of approved scientific calculators. Well before the examination, you should check that your calculator is approved.

The list of approved scientific calculators, as well as the separate criteria for calculators in the General Mathematics examination, can be found on the Board's website at

www.boardofstudies.nsw.edu.au/manuals/#calculatorsforhscexam.

- (v) Where students are permitted to take dictionaries into a Language examination, they must be monolingual and/or bilingual print dictionaries. Dictionaries cannot be annotated or highlighted in any way, including using stickers to mark a particular place. Electronic dictionaries are not permitted.
- (vi) You are not permitted to borrow equipment during examinations.
- (vii) Presiding officers and supervisors will not be responsible for the safe-keeping of any unauthorised material and equipment that has been confiscated, including mobile telephones or other electronic devices.

20. Examination room procedures

- (i) You must sit at the desk with the place card showing your name and student number. The position of the desk may vary from session to session according to the accommodation and the requirements of the examination.
- (ii) You must remove your watch and place it in clear view on the examination desk.
- (iii) It is your responsibility to make sure that the correct examination paper has been provided for the course you have entered. When asked to do so by the supervisor, you must also check examination papers to make sure that there are no pages missing.
- (iv) Reading time for examination papers is as follows:
 - 10 minutes of reading and familiarisation time for the first paper of the examination in all English courses
 - 10 minutes reading time for all written language examinations for Beginners, Background Speakers and Extension courses, and for Continuers courses in modern languages
 - 5 minutes reading time for all other examinations.
- (v) During reading time, you must not write, use any equipment including highlighters, or annotate your exam paper in any way.
- (vi) For examinations where dictionaries are permitted, you may consult your dictionary during reading time.
- (vii) During written examinations, you must:
 - (a) read the instructions on the examination paper carefully as well as all questions. Presiding officers and supervisors are not permitted to interpret examination questions or instructions relating to questions;
 - (b) write your examination centre number and student number on all writing booklets, special answer books and answer sheets;
 - (c) write with black or blue pen. Pencil may be used only where specifically directed;
 - (d) make sure that you write your answers in the correct answer booklets. If you write an answer in the wrong booklet, tell the supervisor, and write a note on the front and back of both booklets that an answer has been written in the wrong booklet. Do not rewrite your answers, but ensure you label and hand in all parts of your answers;
 - (e) stop writing immediately when told to do so by the supervisor;
 - (f) arrange completed answers according to the supervisor's instructions and wait for the supervisor to collect them; and
 - (g) complete the Student Completion Record listing the number of examination booklets used during the examination. This must be checked and countersigned by the supervisor before you leave the examination desk.
- (viii) You must not:
 - (a) begin writing until instructed to do so by the presiding officer or supervisor
 - (b) write your name or your school's name on writing booklets, answer books or sheets, or use any other names, symbols or marks that identify or distinguish you in any way from other students. The Board may cancel your entry if you disregard this rule

- (c) leave the examination room (except in an emergency) until one hour after the start of the examination. If you have to leave and want to return and resume the examination, you must be supervised while you are absent from the examination room
- (d) leave the examination room during the last 15 minutes of the examination. If you have completed the examination you must remain seated and quiet
- (e) remove an examination paper from the examination room until the examination is over.

21. Conduct during the examinations

- (i) You must follow the day-to-day rules of the school or institute where you sit for your examinations. Failure to observe these rules may result in zero marks for the examination, no result for the course or non-award of a Higher School Certificate.
- (ii) The presiding officer and examination supervisors are in charge of students:
 - (a) when assembling before an examination;
 - (b) during the examination; and
 - (c) after the examination until all students have left.
- (iii) You must follow the supervisors' instructions at all times and must behave in a polite and courteous manner towards the supervisors and other students.
- (iv) You must not:
 - (a) take a mobile phone or programmable watch or device into the examination room
 - (b) take any electronic device including a digital media player into the examination room, unless approved by the Board of Studies
 - (c) speak to any person other than a supervisor during an examination
 - (d) behave in any way likely to disturb the work of any other student or upset the conduct of the examination
 - (e) attend an examination while under the influence of alcohol or illegal drugs
 - (f) take into the examination room, or refer to during the examination, any books or notes, this booklet, the examination timetable, any paper, or any equipment other than the equipment listed in the examination timetable
 - (g) smoke in the examination room
 - (h) eat in the examination room except as approved by the presiding officer, eg for diabetic students
 - (i) take any writing booklets, whether used or not, from the examination room. Examination question papers may be removed at the end of the examination only if they are not to be used as answer booklets.
- (v) If you do not follow these rules, or if you cheat in the examinations in any way, you may be asked to leave the examination room and will be reported to the Board of Studies. The penalty may be cancellation of the course concerned, or of all courses, and as a consequence you may be ineligible for a Higher School Certificate.

- (vi) If you do not make a serious attempt at an examination, you may not receive a result in that course and may not be eligible for the award of the Higher School Certificate. Students are required to attempt a range of question types throughout the examination paper. Simply attempting multiple-choice questions is not sufficient for an attempt to be considered serious. Supervisors of marking will bring to the Board's attention examination answers that contain frivolous or objectionable material.

Answers not written in English, except where required or permitted by the question paper, will have zero marks awarded.

- (vii) Actions which breach the examination rules and may also be illegal will be reported to the police.

22. Illness/misadventure appeals

If you believe that your performance in the examination was diminished because of circumstances beyond your control, you can lodge an illness/misadventure appeal.

- (i) If you were prevented from attending an examination, or you consider that your performance was affected by illness or misadventure immediately before or during the examination, it is your right and responsibility to lodge an appeal.
- (ii) Appeal forms and the Illness/Misadventure Information Guide for Students are available from the presiding officer or your principal. These documents provide further details of appeal procedures, and it is important that you follow the instructions provided.
- (iii) You must retain the acknowledgement slip from the illness/misadventure appeal form signed by the presiding officer or principal.
- (iv) The illness/misadventure appeals process does not cover:
- difficulties in preparation or loss of preparation time
 - alleged deficiencies in teaching
 - loss of study time or facilities prior to the formal study vacation
 - misreading of the timetable
 - misreading of examination instructions
 - failure to enter for the examination in the correct course
 - long-term illness such as glandular fever, asthma and epilepsy – unless there is evidence of a sudden recurrence during the examination
 - courses which are undertaken as a self-tuition student.
- (v) If you have been granted special examination provisions such as extra time, you are generally not eligible for an illness/misadventure appeal unless you experience additional difficulties during the examinations.
- (vi) It is important that you attend the examinations where possible, even in the case of illness/misadventure. The Board will not uphold an illness/misadventure appeal if the reason for your absence is not considered to be sufficiently serious. You should consult your school principal before deciding not to attend an examination. Advice from a relevant independent expert, such as a doctor or a police officer, must also be provided with your appeal, indicating why you were unfit to attend the examination.

- (vii) If your appeal is upheld, you will be awarded the higher of your examination mark and your moderated assessment mark as your examination mark. Your Record of Achievement will indicate if the assessment mark is used.
- (viii) You must lodge any illness/misadventure appeals for HSC written examinations with the Board (not UAC) shortly after the examination in question. Appeals for practical examinations, performances or submitted works must be lodged within one week of the date of the examination, performance or submission.
- (ix) Late appeals will be considered only in exceptional circumstances. You will be notified of the results of your appeal on the same day as the release of your examination results.

23. Assessment ranking appeals

- (i) After the final HSC examination, you can obtain your rank order for assessment in each course via Students Online or from your school. If you feel that your placement in any course is not correct, you should talk to your teacher and you may apply to your principal for a review.
- (ii) There is no provision for a review of the marks you received for individual assessment tasks. Reviews are limited to the assessment process. The only matters that the school will consider are whether or not:
 - (a) the weightings specified by the school in its assessment program conform with the Board's requirements as detailed in the relevant syllabus
 - (b) the procedures used by the school for determining the final assessment mark comply with its stated assessment program
 - (c) computational or other clerical errors have been made in the determination of the assessment mark.
- (iii) If you wish to apply for a review you must do so by the date specified by the Board. The school will advise you of the outcome of its review, and will advise the Board of any changes to assessment marks.
- (iv) If you are dissatisfied with the outcome of the school review, you may advise your principal that you wish an appeal to be sent to the Board of Studies. You cannot appeal against the marks awarded for individual assessment tasks. The Board will consider only whether:
 - (a) the school review process was adequate for determining items (a), (b) and (c) above
 - (b) the conduct of the review was proper in all respects.
- (v) The Board will not revise the assessment marks or rank order. If the appeal is upheld, the Board will direct the school to carry out a further review. Further details about reviews and appeals are on the assessment appeal form which can be obtained from your school. Appeals to the Board must be lodged at the school by the date on the form. No extension will be considered.

24. Reporting achievement

- (i) For most Board Developed Courses with an external HSC examination, your achievement will be reported against standards that clearly describe the level of knowledge, skills and understanding you have reached.

Your assessment mark and examination mark will be averaged to give an HSC mark. For two-unit courses, the mark will be on a scale from 0–100. All students who reach the minimum standard expected in a course are awarded at least 50. A mark of 50 or more will be accompanied by a description, in a performance band, of the standard the mark represents.

If you are absent from an examination, and do not have an illness/misadventure appeal upheld, you will not receive any result for the course, and that course will not appear on your Record of Achievement.

If you are not awarded an assessment mark in a Board Developed Course because you have failed to complete the required tasks, you will not receive any result in that course, and the course will not appear on your Record of Achievement.

- (ii) For Board Endorsed Courses other than VET courses, the result reported on the Record of Achievement is the assessment mark submitted by the school and/or other provider. These marks are not moderated and cannot be compared with marks awarded for similar courses at other schools.
- (iii) For all VET courses (both Board Developed Courses and Board Endorsed Courses), the course name and unit value will appear on your Record of Achievement. Eligible students will receive an additional VET credential: an AQF VET Certificate and accompanying transcript of competencies achieved, or a Statement of Attainment.

For the Board Developed VET Accounting course, and VET Industry Curriculum Framework courses where you have undertaken the optional HSC examination, your result will be reported as an examination mark and an HSC mark (equal to your examination mark). This will be accompanied by a description, in a performance band, of the standard the mark represents. You will not receive an assessment mark. For all other VET courses, you will not receive an HSC mark.

- (iv) If you have satisfactorily completed the requirements for a Board Developed Life Skills course, this will be recorded on your Record of Achievement with the course name and unit value. You will also receive a Profile of Student Achievement from your school listing the outcomes achieved in each Board Developed Life Skills course.
- (v) If you studied a course with an outside tutor, no assessment mark is reported on the Record of Achievement. If you studied a course at an institution outside your home school, the assessment mark provided by the outside institution is moderated and recorded on the Record of Achievement.

25. HSC documentation

In December, a Higher School Certificate Student Results Summary will be posted to you. This shows your course results and eligibility for the HSC. The package containing your HSC documentation will be posted to you in January.

- (i) Testamur

If you meet all the requirements, you will be awarded a Higher School Certificate. This certificate shows your name and the name of your school.

(ii) Higher School Certificate Record of Achievement

If you satisfactorily complete at least one Preliminary or one HSC course, you will receive a Record of Achievement. Your Record of Achievement will list all the courses you have satisfactorily completed and your results in those courses. It will also list courses satisfactorily completed in previous years.

Courses that you studied but did not complete satisfactorily are not reported on the Record of Achievement.

(iii) Course Report

A Course Report will also be issued for each Board Developed HSC course you have completed and presented for examination. It will show:

- your assessment mark (except in VET courses);
- your examination mark;
- your HSC mark, which is the average of your assessment and examination marks (except in VET courses);
- the performance bands with a description of what a typical student knows and can do at each level of achievement; and
- a graph showing where your HSC mark lies in relation to all candidates' HSC marks for the course.

(iv) If you have achieved units of competency in a VET course, you will also receive an AQF VET Certificate or Statement of Attainment.

(v) If you have completed requirements for one or more Board Developed Life Skills courses, you will also receive a Profile of Student Achievement.

26. Result Notice

Higher School Certificate Result Notices are issued to students who are not enrolled at an accredited school or a school recognised by the Board. Such students are not eligible to receive either a Record of Achievement or a Higher School Certificate testamur. As there are no school-based assessment marks, your HSC mark in each course will be your examination mark.

27. University admission

The Universities Admission Index (UAI) is calculated by the universities. Students wishing to have a UAI calculated must advise their school at the time of HSC entry.

28. Change of address

If the address you provided to the Board of Studies on your Confirmation of Entry changes, you must inform the Board as soon as possible. The Board needs your current address to send you your PIN number for Students Online, advice of dates and venues for practical and Languages oral/speaking examinations, HSC results, and nomination letters for HSC showcase events. If you are requesting a UAI, you must also change your address with UAC.

29. Important dates

Your school will advise you of relevant dates for submitting important forms to the Board of Studies. These dates are also available on the Board's website at www.boardofstudies.nsw.edu.au/events/index.html.

30. Copyright

The Board of Studies publishes a range of materials based on the HSC examinations that includes samples of students' work. These publications are made available in printed or electronic form and are published solely for educational purposes, that is, to enhance teachers' and students' understanding of the standards required in the HSC examinations.

Answers provided by students for both written examinations and submitted works may be used by the Board of Studies in these publications. In order to maintain the confidentiality of the examination process, individual students will not be identified by name in the publications.

Video or audio tape may be used to record students' performances in courses that require practical examinations. These tapes may be published by the Board of Studies to demonstrate student performance.

31. Important information about your privacy

The Technical Committee on Scaling calculates your Universities Admission Index (UAI) on behalf of the Universities Admissions Centre (UAC). The Board of Studies will provide to the Technical Committee on Scaling, UAC and TAFENSW the personal details and results of all NSW HSC students. In addition, your school or TAFE college and, where applicable, your school system (for example, the Department of Education and Training or the Catholic Education Commission) can access information regarding your results.
